Judge Moore asked the Fiscal Court Clerk to read into the record Resolution 10-17, A RESOLUTION OF THE BOONE COUNTY FISCAL COURT SUPPORTING THE WASTE TIRE TRUST FUND. Mary Dickey, Solid Waste Coordinator, gave an overview of the resolution. Commissioner Kenner moved, seconded by Commissioner Flaig, to approve the resolution. Judge Moore called for a vote on the motion, ALL PRESENT VOTING 4-0.

Judge Moore asked the Fiscal Court Clerk to read into the record Resolution 10-18, A RESOLUTION RELATING TO THE BOONE COUNTY FISCAL COURT APPROVING AN AGREEMENT WITH THE KENTUCKY TRANSPORTATION CABINET RELATING TO THE IMPROVEMENT AND MAINTENANCE OF CERTAIN LANDSCAPABLE MEDIANS INSTALLED ALONG SECTIONS OF NORTH BEND ROAD. Commissioner Kenner moved, seconded by Commissioner Moore, to approve the resolution. Judge Moore called for a vote on the motion, ALL PRESENT VOTING 4-0.

Judge Moore asked the Fiscal Court Clerk to read into the record Resolution 10-19, First Reading, A RESOLUTION OF THE FISCAL COURT OF THE COUNTY OF BOONE, KENTUCKY DESIGNATING A RECOVERY ZONE FOR PURPOSES OF SECTIONS 1400U-1, 1400U-2 AND 1400U-3 OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED.
