### RETHINK TIRES!

**LAST CHANCE IN 2011 TO GET RID OF TIRES FREE: Tire Amnesty Programs are coming to Boone, Campbell & Kenton Counties.** In cooperation with the Cabinet for Energy & Environment, Boone, Campbell and Kenton Counties will be hosting Tire Amnesty. County residents may bring an UNLIMITED number of tires to specific locations in May for FREE disposal. This program only occurs once every four years so now is the time to get rid of those tires. **Tire retailers and tire dealers are prohibited from participating.** Tires on and off of the rims will be accepted but the following **WILL NOT be accepted:** foam filled tires, off-road construction and equipment tires, and solid tires with pressed-on rims or tires larger than tractor size.

**BOONE:** From **May 4<sup>th</sup>-7<sup>th</sup>** between the hours of 8:00 am to 6:00 pm, bring tires to the Boone County Public Works Yard at the end of Maplewood Drive in Burlington (past the Fairgrounds. Bavarian Landfill will also host the Tire Amnesty on **May 4<sup>th</sup> -7<sup>th</sup>** from 8:00 am to 6:00 pm at its facility at the end of McCoy Fork Road just outside of Walton.
