At the Tuesday, July 13, 2010 meeting of the Boone County Fiscal Court, a resolution was approved allowing Judge/Executive Gary Moore to enter into an annexation agreement with the city of Union.

This agreement would indicate the county's willingness for a 43.25 acre parcel to be annexed into the Union city limits. This would allow for future partnerships with the city and county to develop and enhance the property. This property is the current location for the [Union Pool](#).
