

EXECUTIVE ORDER 2021 – EO No. 4 (COV19)

AN ORDER AMENDING THE DEADLINE FOR BUSINESS TAX RETURN FILINGS FOR THE 2020 TAX YEAR.

WHEREAS, our Country and County is responding to the Public Health threat posed by the Coronavirus Disease (COVID-19) and Emergency Declarations have been issued by the President and Governor; and

WHEREAS, this office has previously issued an Emergency Declaration pursuant to KRS 39A.100 (2) and 45A.380 (1) (7) on March 13, 2020;

WHEREAS, KRS 39A.180(1) authorizes political subdivisions of the State, under an Emergency Declaration, to “make, amend, and rescind orders and promulgate administrative regulations necessary for disaster and emergency response purposes”; and

WHEREAS, the Treasury Department and Internal Revenue Service have recently announced that the Federal Income Tax filing due date for individuals for the 2020 tax year will be extended from April 15, 2021 to May 17, 2021; and

WHEREAS, Boone County’s Business License Ordinance also stipulates a normal filing deadline of April 15th of each year and requires a copy of the Federal Income Tax Return for each filer; and

WHEREAS, it is now necessary for the County to amend its normal filing deadline to align with the May 17th filing deadline recently announced by Federal Government Agencies.

NOW, THEREFORE, I, Gary W. Moore, County Judge/Executive, do hereby approve the change of the County’s normal business license tax annual due date from April 15th to May 17th of 2021.
