ITEM III.

PRESENTATIONS

A. Judge Moore introduced Sheriff Mike Helmig to present the Sheriff Budget for Fiscal Year 2021 which is created on the calendar year. Sheriff Helmig stated the Budget for 2021 will be \$22,529,639.00 which will include the standard 3% performance raise; this year all deputy positions are filled and the Budget includes a new starting rate for Deputies. Commissioner Kenner asked a question, Sheriff Helmig responded.

Judge Moore asked the Fiscal Court Clerk to read into the Record Item VII. A: A RESOLUTION RELATING TO THE BOONE COUNTY FISCAL COURT APPROVING THE SHERIFF'S BUDGET, GENERAL TERM ORDER, AND ANNUAL ORDER SETTING MAXIMUM AMOUNT FOR DEPUTIES AND ASSISTANTS OF THE BOONE COUNTY SHERIFF'S DEPARTMENT FOR THE CALENDAR YEAR 2021. Commissioner Brewer moved, seconded by Commissioner Kenner, to approve the Resolution. Judge Moore called for a vote on the motion, ALL PRESENT VOTING - AYE 4-0.

B. Judge Moore introduced Laura Pleiman the Director of Human Services. Laura presented the FY2021 MH/ID/Aging Capital Project Funding Report. The organizations that have requested funds this year are The Point/Scheben Care Center for capital renovations, Brighton Center for computers and NKY CAC for a Van for transportation. The total amount requested by the agencies was \$226,797.00 but the actual awarded amount recommended by the Tax Board was \$49,500.

Commissioner Kenner moved, seconded by Commissioner Flaig, to approve the Resolution. Judge Moore called for a vote on the motion, ALL PRESENT VOTING - AYE 4-0.
